3. Resolution 16-37, To Authorize the Issuance of Refunding Bonds

Paul Wyzgoski, Dickenson & Wright Bond Counsel, explained the purpose of the resolution before the Board tonight. The county bonds for the Courthouse expansion were originally taken out back in 2002. The bond was refinanced earlier in 2007. Dickenson & Wright are suggesting that we refinance them again for a cost savings of approximately \$450,000 over the life of the bond without extending the payoff date.

He also mentioned that he has stopped by the USDA office last week to thank them for going above and beyond by working with the City of Cadillac and Granger to have them work together on the sewer project. He then touched on the 911 service. Some jurisdictions see dispatch as State mandated, but it is not.

Donald Koschmider, Cadillac, expressed concern about MSP TNT Center.

Liaison Reports

Comm Theobald, as the liaison for DHHS, will be providing the Commission with a written report as they have much going on.

Comm Taylor had a Veteran's Service meeting today with Renee Haley present. They believe the consolidation service agreement between Clare County and Wexford County has been worked out.

Comm Housler attended a North Flight meeting and they have entered into a joint venue with Spectrum in Grand Rapids. They seem to have a licensing problem that they are continuing to work on. They have their big helicopter now and are working on new hangars. They have three and are working on a new one. The joint venture is working well.

Board Comment

Comm Theobald explained that the Airport grant will be \$3.4 million of Federal Funding over the next 5 years. In 2017, the project they would be working on will be at a cost of \$670,000 with a portion to come from the City and County (\$33,500 City; \$20,100 County). Never Down for the Count has scheduled a benefit banquet for 10/15 with a silent auction.

Comm Taylor congratulated Robert Colvin for being named Citizen of the Year in Manton.

Comm Fuscone would like to see the BOC follow through with their hiring freeze beyond 2017. He believes cuts are needed and he would like to see the BOC stick with it.

Comm Howie believes that the 911 surcharge is a sneak tax. He would like to see a tax reduction if the surcharge is voted in.
